Is Mozambique a good place to invest in solar energy?

Mozambique has an abundant and unexploited solar resource which could be harnessed for utility scale as well as residential PV for both on/off grid electrification. The following map shows the global horizontal irradiation profile of Mozambique which varies between 1,785 and 2,206 kWh/m²/year.

What is get fit Mozambique - solar PV + Bess tender?

Currently, the first two tender windows are in preparation: GET FiT Mozambique - Solar PV + BESS tender facilitates investments in grid-connected Solar PV IPP Projects with energy storage. EDM acts as the IPP's counterpart in Power Purchase Agreements (PPA) and energy off-take.

Why is Mozambique acquiring 25-30 MW of solar PV?

The procurement of 25-30 MW of solar PV is the first stage of implementation of the program which will contribute to the diversification of Mozambique's power mix and improve power supply quality, whilst ensuring low-cost energy for Mozambican end users

What is PV power potential in Mozambique?

The PV power potential map developed by the World Bank shows the potential for PV power projects in Mozambique on a scale of a yearly total specific PV power output of 1,534 to 1,753 kWh/kWp. The zones marked in the darkest shade show the highest potential .
