When will photovoltaic export tax rebates be canceled?

The announcement, jointly issued by the Ministry of Finance and the State Taxation Administration, said that export tax rebates for the value added tax of photovoltaic products will be canceled starting from April 1, 2026.

Tax Credit: A direct dollar-for-dollar deduction off of your income taxes that you would normally pay to the federal government. Tax Deduction: Deduction of taxable income that can increase your refund or reduce how much tax you owe.

Do solar rebates work?

Several states offer rebate programs that cover some or all of the cost of purchasing a home solar system and/or battery storage. These rebates can work in addition with the federal tax credit to increase the savings of going solar. For example: Maryland offers a \$1,000 rebate for solar photovoltaic and solar shingle installations above 1 kW.
